

**Special Section on Enriched Multimedia**  
**- Media technologies opening up the future -**  
submit by **March 2, 2023**, published in **January 2024**

The Institute of Electronics, Information and Communication Engineers (IEICE) announces a forthcoming special section on “Enriched Multimedia” to be published in Transactions on Information and Systems. We invite submissions of original and unpublished papers that review and promote recent progress in the field of enriched multimedia.

**1. Scope**

The following topics fall within the scope of this special section. However, the submissions of papers on other topics conforming to the aim of this special section is encouraged.

- *Protect content value* — Content Security, Non-Fungible Token, Access Control, Fingerprinting, Steganography
- *Develop content value* — Content Integration, Cross-media Retrieval, Media Restoration, Machine Learning for Media Applications, Multimedia Abstraction
- *Create content value* — Content Design, Realistic Media Creation, Universal Media, Digital Entertainment
- *Measure content value* — Content Evaluation, Image/Audio Quality Measurement, Perception/Cognitive Metrics, Human Audiovisual System

**2. Submission Guidelines:**

- The manuscript should be prepared in accordance with the guidelines given in “*The Information for Authors*” ([https://www.ieice.org/eng/shiori/mokuji\\_iss.html](https://www.ieice.org/eng/shiori/mokuji_iss.html)). Authors are encouraged to use the IEICE Style File (<https://www.ieice.org/ftp/index-e.html>). The preferred length is eight pages for a PAPER and two pages for a LETTER with the format shown in the IEICE Style File.
- **Submit the manuscript through the IEICE Web site** ([https://review.ieice.org/regist/regist\\_baseinfo\\_e.aspx](https://review.ieice.org/regist/regist_baseinfo_e.aspx)). Choose “[**Special-MU**] **Enriched Multimedia**” from the menu for “Journal/Section” on the submission page.
- In the initial submission, not only a manuscript PDF file for PAPER/LETTER but also the related electronic files (TeX/Word files for body and independent figure files, furthermore, authors’ photos and biography if the manuscript type is PAPER) are required.
- Submission deadline for manuscripts is **March 2, 2023**.

**3. Notice to the Authors:**

- Authors must agree to the "Copyright Transfer, Article Processing Charge Agreement, Notices from the IEICE, and Privacy Policy" via electronic submission.
- Upon accepted for publication, all authors, including authors of invited papers, should pay the page charges covering partial cost of publication by October 14, 2023. If payment is not completed by that date, your manuscript will be handled as rejection.
- The standard period between notification of conditional acceptance and the second submission is 60 days. It may be shortened in accordance with the review schedule.
- If there are non-members among the authors, the non-member authors are encouraged to take this opportunity to join the IEICE. If all authors are non-members, the article processing charge for non-members will be applied, except for invited papers.
